PRODUCT DESCRIPTION:

CX 88 is a concentrated carpet extraction cleaner formulated with environmentally preferred chemicals that incorporates proprietary encapsulation technology for superior maintenance of all types of stain resistant and untreated carpeting. The encapsulated soil particles release from the fiber and are easily extracted with normal vacuuming.

USES:

Use as a pre-spray to pre-treat soils/stains. CX 88 is an excellent traffic lane cleaner that resists re-soiling long after application.

It is recommended that protective gloves and safety glasses be worn when using this and all cleaning products.

Before product use follow these preliminary steps:

Remove all furniture/objects from the area to be cleaned.



1. Dry vacuum area thoroughly.



2. Pre-test product at use dilution in an inconspicuous location to determine possible color damage. If area exhibits any color variation, bleeding or material shrinkage, DO NOT USE.

DIRECTIONS FOR EXTRACTION CLEANER/CARPET PRE-SPRAY:



1. Pre-treat any spots or stains using pre-spray solution at 8 oz. **CX 88** per gallon of cold water (1:16).

Clean carpet following machine manufacturer instructions using extraction dilution at 1 oz. CX 88 per gallon of cold water (1:128). Do not over-saturate carpet.



2. After cleaning, carpet pile can be brushed using a pile brush.



3. Allow carpet to dry thoroughly then dry vacuum.

DIRECTIONS FOR TRAFFIC LANE/BONNET CLEANER:



1. For lightly soiled carpets, apply **CX 88** solution at 8 oz. per gallon of cold water (1:16) on carpet and bonnet until wet to the touch and rotary bonnet buff.

For heavily soiled areas, dilute 8 oz. **CX 88** per gallon of cold water (1:16) in a wringer bucket. Soak bonnet pad in solution, wring out thoroughly then rotary bonnet buff.



To quicken process, use two buckets and two bonnet pads; one for rinsing and one for cleaning.



2. If using a rotary machine with solution tank, pour diluted **CX 88** (8 oz. per gallon of water) into tank, release solution into bonnet and buff. Do not over-saturate carpet. Traffic may resume as soon as carpet is dry (approximately 30 minutes.)
