

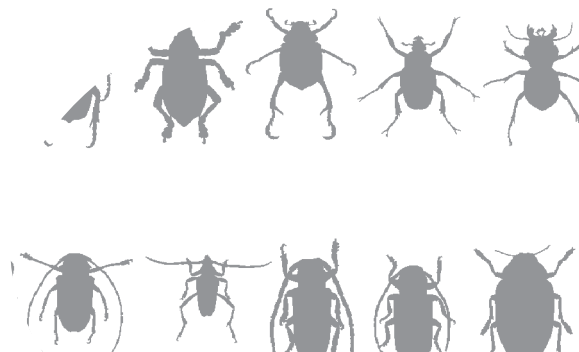

A ready to use residual insecticide for crawling insects formulated with BAYGON® solubilized in an oil base.

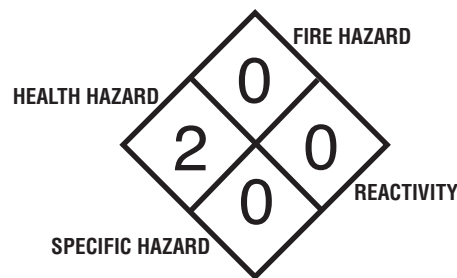
1. Ready-to-use formula. Spray a light amount onto areas to be treated (into cracks, crevices, around base boards and other places insects hide) using a power operated or hand sprayer.
2. Make sure surface is dry before allowing children, adults or pets into the treated area.
3. Close container after use. Store in a cool, dry place. Do not store near heat or open flame. Do not reuse container. Once container is empty, place in trash or offer for recycling if available.

NOTE: Do not apply to rugs, draperies, wallpaper or similar materials that may be stained. Avoid excessive wetting of plastic, rubber and asphalt surfaces such as tiles and floor coverings.
